Interpretation/Analysis of Curriculum/Syllabus feedback for the academic year 2020-21 from all the stake holders of education institute. It includes the opinions or feedback about Curriculum/Syllabus of courses from the Parent, Industrialist, Management, Alumni, Teaching, Non Teaching, Students, Common People nearby College, etc Total 253 feedbacks have been collected from all stake holder of Education Institute.

Feedback has been collected through online mode with pre designed structure questionnaire. It would be helped to understand the views or opinions of stakeholders about Curriculum/Syllabus and It would be easy to sent or convey the same during the meeting or workshop of Syllabus Board of Mumbai University. A. Relation with the college Total 213 feedback has been collected from the all the stake holder of Education Institute. It consists of Parent-12.2%, Industrialist- 1% Management-1.4%, Alumni-1.4%, Teaching6.1%, Non Teaching-1.4%, Student 73.7 %, Common People nearby College-2.8%, Interpretation: - It is indicated that all stakeholder of Education Institute are actively participated in feedback of on Curriculum/Syllabus for the academic year 2020-21. 1. How do you rate the curriculum (Syllabus)? Almost 100 percent of respondents are favoured about the curriculum (Syllabus) of B.Com and M.Com are suitable. It consist of 26.8 percent are opinioned that it is excellent and 43.2 percent is opinioned that it is very good respectively.28.6 percent is rated as good. Interpretation: - It is indicated that all stakeholder satisfied about curriculum (Syllabus) of B.Com and M.Com.

Approximate 83% students responded that the depth of the course content is adequate in relation to the expected course outcomes whereas 78% students has given average response. Approximate 84% students responded that the syllabus of the subject is career oriented whereas 16% students responded average satisfaction level. 83 % students are satisfied with the sequential arrangement of the units in the syllabus and 17% students are feeling burden of the syllabus in NSS College of Commerce & Economics / Feedback analysis the sense of size of the syllabus for limited period of semesters. 75% students reported that they are strongly agree with the relevance of the objectives with the course contents. 77 % students reported that the design of the courses in terms of extra learning or self-learning considering is excellent. Around 83% students answered that the syllabus has good balance between theory and application. Approximately 89% students answered that the syllabus has helped to improve their ability to formulate, analyze and solve problems. More than 85% of the students stated that the curriculum is helpful for their employability as well as for various competitive examinations.

Summary: Some deficit issues on curriculum came out from the analysis were communicated to the Member of the Board of Studies of respective subjects for their consideration. Further the teachers have been taken part in the reformation of curriculum of respective subjects and suggested the modifications for the betterment of the curriculum.

1. How do you rate the curriculum (Syllabus)?

3. Are the subjects relevant to your job and your future aspirations?

43 percent respondents are rated as to subjects or syllabus for job and future aspirations. 33 percent respondents are rated as Very good to subjects or syllabus for job and future aspirations 24 percent respondents are rated as good to subjects or syllabus for job and future aspirations.

Interpretation: - It is indicated that all stakeholder satisfied about subjects or syllabus for job and future aspirations.

4. Whether the subject knowledge is useful for day today life?

44 percent respondents are rated as Excellent to subject knowledge is useful for day today life. 37.1 percent respondents are rated as Very Good to subject knowledge is useful for day today life. 35 percent respondents are rated as Good to subject knowledge is useful for day today life. 21 percent respondents are rated as Fair to subject knowledge is useful for day today life.

Interpretation: - It is indicated that all stakeholder satisfied about subjects or syllabus knowledge is useful for day today life.

5. Do you think the subject/course helps in developing Students personality?

43 percent respondents are rated as Excellent to subject/course helps in developing Students personality. 38 percent respondents are rated as Very Good to subject/course helps in developing Students personality. 19 percent respondents are rated as Good to subject/course helps in developing Students personality.

6. How do you rate the paper pattern and exam evaluation system?


